1. Introduction

- 1.1. These terms and conditions shall govern your use of our website.
- 1.2. By using our website and services, you accept these terms and conditions in full; accordingly, if you disagree with these terms and conditions or any part of these terms and conditions, you must not use our website.
- 1.3. If you register with our website, submit any material to our website or use any of our website services, we will ask you to expressly agree to these terms and conditions.
- 1.4. You must be at least sixteen (16) years of age to use our website; by using our website or agreeing to these terms and conditions, you warrant and represent to us that you are at least sixteen (16).
- 1.5. Information supplied to our website, or in relation to our website should be true, accurate, current, complete and non-misleading.
- 1.6. Our website uses cookies; by using our website or agreeing to these terms and conditions, you consent to our use of cookies in accordance with the terms of our [Privacy Policy](#).

2. Offered Services

In accordance with these Find Geek Spots B.V. "Packages" means subscriptions products that are offered to the Customer for purchase.



“Services” means the services offered by Find Geek Spots B.V. and its website www.findgeekspots.com.

“Website” means the website of Find Geek Spots B.V. www.findgeekspots.com.

4. Licences to use Business Listing Services

- 4.1. Licences are granted by Find Geek Spots a non-exclusive, non-transferable to access the Business Listing Services of Find Geek Spots in accordance with the terms of this Agreement for the duration of the Subscription Term.

 - l. blasphemous material;
 - m. any material that is in contempt of any court, or breach of any court order;
 - n. spam, chain letters.

10. Business Listing Services

- 10.1. Authorized person of a company may submit on behalf of a company a business listing to our directory.
- 10.2. You can choose to use our free business directory listing services or our paid business directory listing services.
- 10.3. Subscribing to the Business Listing Services for Business of Find Geek Spots is by signing up web-based, by clicking on the Add Listing button and choose a Package (free or paid).
- 10.4. If your company/organization has already been added to our database, you must contact us immediately by clicking on the claim button or by sending us an email. We will contact you by phone or email. After verifying the information that has been provided to us, you will be able to choose a Package that we offer on our website.
- 10.5. Find Geek Spots B.V. holds the right to delete or reject a business directory submission that is not according to the provisions of these terms and conditions, breach of the terms and conditions, or does not meet the available guidelines.

11. Fees and Payment of the paid Business Listing Services

- 11.7. In case of an unsuccessful payment by PayPal or a bank wire transfer, you will be liable to pay us within Seven (7) days commencing the date of our written request:
 - a. the amount equal to the unsuccessful payment;
 - b. all expenses in relation to the unsuccessful payment, including the expenses made by our bank or your bank or payment processor;

- c. the administration fee is 20 Euros excl. VAT;
 - d. all justified and reasonable costs incurred by Find Geek Spots to recover the amount stated in Section 11.7. subject a., including but not limited to debt collection fees and any necessary legal fees.
- 11.8. Your account might be suspended if you owe us any amount that is subjected to these terms and conditions until the payment has been successfully conducted.
- 11.9. Should you change your mind about your Purchased Package, you must contact us within seven (7) days after your Purchase date to obtain a full refund of your fee. The refund of fees will be carried out in 48 hours.

12. Subscription Term for free and paid Business Listing Services

- 12.1. The term of a free Subscription is indefinite.
- 12.2. Find Geek Spots holds the right to remove/delete a free business listing in our business listing directory in our sole discretion with or without explanation or notification.
- 12.3. Subscription Term for paid Business Listing Services, and to enjoy the services of a paid account, is mentioned in the Packages offered on our website; five (5) days before the end of the paid Business Listing Services you will receive a message/email from Find Geek Spots regarding recurring payments should you wish to extend your paid membership (please follow the given instructions provided).

13. Customer Content License
